

## Board Meeting - August 14, 2025

The Tri-Center Board of Education met August 14, 2025 at 6:00 p.m. in the HS Library.

Board members present were: President Sara Arnold; Board Members: Mike Olsen and Amanda Scherer. Board members Katie Ausdemore and Jeremy VanArsdol were unable to attend due to prior obligations. President Arnold called the meeting to order at 6:00 p.m.

Motion by Olsen with a second by Scherer to approve the agenda as presented. Motion carried 3-0.

Motion by Olsen with a second by Scherer approving the consent agenda including paying the bills, approval of financial reports and the minutes from the previous board meeting. Motion carried 3-0.
